RE: 15-FOIA-203 Lobbying Contract - William Lipinski

Dear Ms. Sweet:

We are in receipt of your request under the Illinois Freedom of Information Act, 5 ILCS 140/1 et seq.

I. <u>Background</u>

On October 2, 2015, we received your request for a copy of William Lipinski's contract with Metra ("**Request**").

II. <u>Responsive Document</u>

In response to your Request, Metra is providing you with a copy of the Professional Consulting Service Agreement #S41053 between Mr. Lipinski's company, Capricorn Communications, LLC and Metra ("**Responsive Document**").

III. Partial Denial

While FOIA requires public bodies to provide access to public records generally, Section 7(1)(s) of FOIA authorizes units of government to withhold "[a]ny and all proprietary information and records related to the operation of an intergovernmental risk management association or self-insurance pool or jointly self-administered health and accident cooperative or pool Insurance or self insurance (including any intergovernmental risk management association or self insurance (including management information, records, data, advice or communications." 5 ILCS 140/7(1)(s). Accordingly, per Attorney Thomas Stuebner, all information regarding insurance within the Responsive Document has been redacted.

IV. <u>Right of Review</u>

You have the right to have the partial denial of your Request reviewed by the Public Access Counselor ("**PAC**") of the Illinois Attorney General's Office. 5 ILCS 140/9.5(a). You can file your Request for Review with the PAC by writing to:

If you choose to file a Request for Review with the PAC, you must do so within 60 calendar days of the date of this partial denial letter. 5 ILCS 140/9.5(a). Please note that you must include a copy of your original FOIA request and this partial denial letter when filing a Request for Review with the PAC.

You also have the right to seek judicial review of your partial denial by filing a lawsuit in the circuit court. 5 ILCS 140/11.
